Acceptance & Release

Parent/Guardian - Please initial each box acknowledging your informed acceptance:

I have monitored my daughter for the past 14 days and confirm that she has not exhibited the following symptoms during that time:

- Fever or feeling feverish (chills, sweating)
- New cough
- Difficulty breathing
- Sore throat
- Muscle aches or body aches
- Vomiting or diarrhea
- New loss of taste or smell

I have monitored my daughter for the past 14 days and confirm that she has had reasonably limited in-person time with non-household individuals, whenever possible. If she did have in-person time with non-household individuals or attended large gatherings or events (such as birthday parties, weddings, eating inside restaurants, etc.), I confirm that she wore an appropriate mask AND practiced effective social distancing (remaining 3-6 feet apart and reduced time spent near other non-household individuals to less than 15 minutes).

I have read the current WeHaKee COVID-19 Guidebook and reviewed it with my daughter to ensure she understands the guidance and expectations. I confirm that she (i) shall abide by WeHaKee's COVID-19 related obligations and protocols, (ii) recognizes that these conditions are subject to change at any time, and (iii) accepts all risks of COVID-19 arising out of her attending WeHaKee during the summer of 2021.

I confirm that I understand that the risk remains that my daughter may be exposed to the COVID-19 virus while attending WeHaKee Camp for Girls and that I have assessed the risks for my child's health and safety in making my decision to allow her to attend WeHaKee in Summer, 2021.

I confirm that I have a plan in place to be able to retrieve my child from WeHaKee Camp for Girls within 48 hours in the event my child is confirmed to be COVID-19 positive.
