- * On ARRIVAL DAY flights should be scheduled to arrive MSP between 11:00 and 16:00 (4pm) CDT and on DEPARTURE DAY, flights should be scheduled to depart MSP between 12:00 and 17:00 (5pm) CDT. CONTACT WEHAKEE BEFORE BOOKING FLIGHTS if you are unable to find appropriately scheduled flights. Although we will do our best, we cannot guarantee we will be able to accommodate all flights outside of these times.
- * **BE PREPARED FOR ADDITIONAL AIRLINE FEES ON DEPARTURE!** Airlines do not accept cash payments at ticketing/check-in counters! Campers may be assessed additional fees for extra or overweight baggage, unaccompanied minor fees or other charges. We STRONGLY ENCOURAGE YOU to provide your daughter with a pre-paid credit card to cover such expenses. This will eliminate delays and possibly missed flights! If WeHaKee staff cover these expenses, WeHaKee reserves the right to charge (in addition to the assessed fee) a 25% or more surcharge. Avoid the surcharge and check-in delays with a pre-paid credit card!
